Privacy Policy

Your privacy is taken very seriously. This privacy policy describes when personal information is collected, what personal information is collected, and how it is used.

When do we collect information from you?

We collect information from you when you:

- Contact us using our email contact form
- Place an order with us for goods/services which:
 - require follow up communication from us (special orders, repairs, etc to advise goods ready for pick up or installation)
 - o and/or require us to attend your designated site to provide goods/services
 - o and/or require authorisation to request the goods/service (e.g. restricted keys)
- Apply for a 30 day Business Trading Account
- Provide feedback to us regarding your experience in dealing with us

We do not require personal information when you:

- attend our front counter at 51 Kembla Street Fyshwick
- and purchase goods/services for immediate payment (cash sale)
 - o which do not require follow up communication
 - o do not require us to attend your designated site
 - \circ do not require authorisation

What information do we collect?

We collect your name, phone number, email address, and fax number so we can contact you regarding your enquiry or order.

We also collect your delivery address for payment details regarding any purchases and/or the appropriate site address for provision of on-site services. (On rare occasions for C.O.D. services - when you are unable to be on site to make payment we temporarily hold your credit card details and delete them once the job is done and payment has been processed).

For businesses wishing to establish a Trading Account - refer to our "Application for Trading Account" (available on the Downloads section of our website) for details which are collected in the establishment of a Trading Account Agreement.

We collect details of your experience in dealing with us when you provide feedback so that we can better understand your needs and values and to improve our customer service and your level of satisfaction.



What do we use your information for?

- To contact you regarding an enquiry, order, or complaint
- To deliver goods/services that you have purchased
- To establish a Trading Account for businesses
- To understand what you value (from your feedback) and to improve our service to you

How do we protect your information?

Information is maintained confidentially within our computer business and web systems via a number of stringent security measures which limit access to your information to our authorised personnel only.

We do not sell, trade, or otherwise transfer to outside parties your personally identifiable information.

We require our trusted third parties who assist us in operating our web site, conducting our business, or servicing you to keep such information confidential.
